Tao Retreats may, in its sole discretion, cancel or change the schedule of all or any part of any program or extension if it considers such action to be in the general interest of participants or their safety, and I waive all claims against Tao Retreats arising from such actions or decisions. Tao Retreats reserves the right to alter the itinerary when necessary. All prices quoted are valid at the time of publication and every effort is made to honor the original published pricing; extraordinary circumstances may warrant revisions and Tao Retreats reserves the right to revise final pricing when necessary.
